Our Campus Leadership Team (staff and parents) meets on an as-needed basis to assess progress on school goals and identify steps to initiate needed changes. Our Parent Teacher Association meets monthly to plan events to increase parental involvement. Currently, Little Rock School District Policy requires schools to hold Campus Leadership Team meetings. No professional development has been provided to assist our staff and parents in effectively utilizing a team approach in planning and decision making.</p>

	Describe current level of development:	<p>Currently, Fulbright Elementary School students are provided rigorous instruction in Common Core State Standards, a college-ready curriculum. Teachers attempt to instill strong work ethics by engaging students in educational experiences that teach them how to think and to solve problems independently and collaboratively. Skills gaps are addressed through the after school tutoring program, Response to Intervention, small group instruction by the reading teacher, resource classes, Little Rock School District Summer School, and Camp Can Do. Students who speak English as a Second Language are instructed by ESL-trained teachers. Keyboarding and other computer skills are taught by the computer lab attendant and classroom teachers.
