McClellan High School has completed its initial comprehensive needs assement by looking at a correlation between the incoming 9th grade scores on EXPLORE, 10th grade PLAN scores for our current 11th graders, and current 11th and 12th grade ACT results. We then looked at discipline and attendance data for these students to make a correlation regarding success barriers. For our ELL students, we looked at ELPA/ELDA scores and the information in Data Dashboard (Data Portal) to see if the modifications for these students might have had bearing on their success on ACT/EXPLORE/PLAN.

We have looked at our 14-15 programs and correlated student success to the student involvemn in the program(s)-i.e. City Year, After School and Before School Tutoring, AVID, Credit Recovery, etc.. The review of the programs through the use of correlated data has provided for the revamping of some programs (AVID, Credit Recovery, City Year, etc.) and deletion of other programs.

McClellan will asssist in coming 9th grades through events like- Freshman Open House/Meet and Greet, Freshman Assembly, Freshman Success Shout-outs, Freshman Parent night, and Big Brother-Big Sister Program (linking Seniors with 9th graders). For our 12th graders, we accomplish transition through hosting the Historically Black College Fair, inviting several college representatives to the campus, and conducting college visits for an entire day on the campuses of UALR, UCA, Philander Smith College, UAPB and other colleges. Our Special Education department is working with transition efforts by hosting monthly onsite visits with PARK-Keith Jackson, Arkansas Promise, Project Search etc. We also have a representative here weekly for Arkansas Rehabilitation Services. The student will also go to Hot Springs' Arkansas Career Technical Insititute in April.

We have two Spanish openings and have been working with various entities ourside of the LRSD Human Resources department to address this need. We have worked with LULAC, ADE Professional License option, Arkansas Virtual School, and begin a partnership with UALR, UAPB, Philander Smith, etc. to work with student teachers to assist them in garnering licenses.
